The following members attended the virtual meeting: Graciela Moreno, Tina Philip, Oscar Garza, Nicole Denise Lopez, Puja Sehgal, Richard Young, and Gerald Banks.

MINUTES

- 1. The meeting was called to order by Graciela Moreno, MD, chair at 6:03 p.m.
- 2. The council report from April 8, 2022 was approved.
- 3. Members discussed topics for a draft agenda for the council's town-hall-style forum at Annual Session in October. Ideas included:
 - a. A discussion or presentation on the outcome of TAFP's resolution on AAFP's policy regarding the CPT coding system.
 - b. A major focus on administrative burdens to perhaps include:
 - i. A discussion among the group on what are the most difficult or time-consuming administrative burdens the assembled members experienced. Question: who should facilitate that discussion?
 - ii. Ensure the discussion has some focus on small practices.
 - iii. Consider in the discussion alternatives to technological solutions, such as medical scribes.
 - iv. A presentation on what AAFP is doing to address administrative burdens.
- 4. The council also discussed recent reports published in the New England Journal of Medicine that questioned the wisdom of pursuing value-based care as a systemwide solution to problems of cost and quality. Those three articles were subsequently shared with the full council.
- 5. Staff will work on a draft agenda for the live forum to send to the council via the TAFP Exchange.
- 6. The meeting was adjourned at 7:03 p.m.
